	Program Costs	We do not anticipate any new cost to implement and sustain the proposed program. No new faculty are required for program implementation. Courses in the program will be taught by existing faculty members in the Adult and Lifelong Learning and Higher Education programs. There are two tenure-track faculty members in the Higher Education program who started in Fall 2018 with a reduced teaching load. Their loads would increase next year to a typical 2-2 load, which would allow the program to offer additional 4 courses a year. One faculty member who is currently serving as a full-time administrator will be returning to a faculty role next year and will be teaching 4 courses as a regular teaching assignment. In total, this increases the teaching capacity of the Higher Education program faculty by 8 courses per year (4 per semester), not including the additional capacity for summer teaching. This Master of Education in Community College Leadership program will not only add to the number of professional master's students at the University of Arkansas and be of service to important educational institutions in our state and region, but it will also help ensure that Higher Education program faculty have full teaching assignments in the future. If the program grows beyond the anticipated enrollment projections, adjunct faculty will be hired to teach courses as needed.

The resources that students will need are already included in the collections and subscriptions related to the Higher Education and Adult and Lifelong Programs. Since the program is a web-based program and students are not on campus they will access resources through electronic means. Throughout the degree program, students will be able to access already existing resources, including the University of Arkansas Library's vast education holdings.

		This request is for a new online Master of Education in Community College Leadership program. Based on the needs assessment, Arkansas community colleges estimate a minimum of 101 job openings in the next 2-5 years that would require or prefer this degree. In addition, they indicated that, at a minimum, 145 current employees would benefit from enrolling in this degree. In addition to Arkansas community colleges, we anticipate recruiting students from northeast Oklahoma, southwest Missouri, and southern Kansas, suggesting an even larger market for this degree. These institutions estimated the annual salaries of positions that would require or prefer this degree ranged from \$35,000-185,000. An approximate average salary for positions that require or prefer this degree was \$60,000. This proposed degree has a potential to improve the preparation of community college workforce and build their content expertise that will correspondingly improve their institutions and their local communities.

Admission to Degree Program: All applicants must have a B.A. or B.S. in a basic or applied science. Applicants must submit transcripts, letters of recommendation, and the CEMB Applicant Profile. Applicants may also wish to present Graduate Record Examination scores for the Verbal and Quantitative tests, and the GRE writing instrument, to enhance their credentials. GRE scores are required to compete for special graduate school fellowships. For consideration for admission, a student must secure a sponsoring faculty member. Individual faculty may require additional materials (GRE, writing examples, etc.). The sponsoring faculty member will submit probable thesis subjects to the Program Committee prior to acceptance of the student. Once an applicant has been approved by the Program Committee, the program submits the application for admission to the Graduate School. Two course tables were combined into one course table. In addition the course sequencing was edited (which gives the impression of more substantive changes than actually occurred). \\n3. Adding goals and objectives. The previous admissions information in the catalog pointed towards the website for information. This catalog update reflects what the program has been requiring and simply provides that detail here in the catalog. \\nThe changes are reflective of a longterm program self study conducted in collaboration with the University Council for Educational Administration (the primary EDLE professional association of which the University of Arkansas is an institutional member) and CPED (The Carnegie Project on the Education Doctorate). They are designed to improve the student cohort's exposure to experiences that help them navigate rigorous research experiences with site-based problems of practice.	The new dissertation methods course that was created last year was added to the program of study. Admissions changes include removing the GRE, moving from 3 to 2 letters of reference and requiring that 1 of them be from a supervisor, clarifying that the writing sample is "prompted" and changing from a specialist required to a master's. The GRE has been optional for several years and we do not find it a useful tool for evaluating working professionals (many who are long time school principals or superintendents by the time they apply to our program). The recommendation letter number is based on several years of experience with applications not moving forward because of delayed responses from letter writers and the value we place on hearing from someone who has supervised their work and can speak to their potential as a future school leader. The rest is simply clarifying details about the program for potential applicants.

	justification of the request	\\nOffer an existing Minor in Supply Chain Management for Non-Business Majors via Distance Technology.\\n 8. Program summary/justification for offering program by distance technology:\\nThe market has moved to online programming to supplement face-to-face courses and/or add to a college's educational offerings. More and more of our peer and aspirant colleges of business have moved to some form of online programming (see for example, http://www.businessinsider.com/harvard-business-school-online-courses-2013-10). In addition, offering a degree online strategically positions the College to capture new markets (e.g., students abroad, degree completion, and adult learners). Supply Chain Undergraduate Degree Labor Market Analysis suggests strong growth for the supply chain labor market. There are seven universities offering online SCMT Bachelor of Science degrees. Cohort schools (SEC and Land-Grant Universities) do not offer online undergraduate degrees in this concentration. There are few state and regional universities that offer supply chain bachelor's degrees (face-to-face or online), which provides an opportunity to serve the needs of the state and region. This is one of the few fields in which Arkansas wage rates are among the highest in the nation. The program also has significant opportunities internationally. The minor for non-business majors supports college and university interdisciplinary efforts, and provides flexibility for students. All courses are already developed or are in development and being offered online. \\n	Removing two courses from the list of required courses for the SCMT minor for non-business students (SCMT 3443-DELIVER: Transportation and Distribution Management and SOURCE: Procurement and Supply Chain Management) and replacing those with the supply chain introduction course (SCMT 2103-Integrated Supply Chain Management). This change increases the number of elective hours from six to twelve. Non-business students will benefit by taking the introductory supply chain management class (SCMT 2103-Integrated Supply Chain Management) before taking more advanced supply chain courses. The change also allows for more elective choices for non-business students seeking a minor in supply chain management.
