Complete an evaluation for internship. Students must also meet the following criteria to be cleared for the internship:

Obtain a "C" or better in the following pre-education core courses: [AGED 1123](#), [CIED 3023/CIED 4023](#), and [CIED 3033](#).

Obtain a "C" or better in concentration education [courses](#). ~~courses: AGED 3111, AGED 3133, ACOM 3143, AGED 4213, AGED 4233, and AGED 4244, AGED 4231, and AGED 4843L.~~

Complete and submit the online application to teacher education through the university-wide Office of Teacher Education and pay the [Teacher Education Application Fee](#). Apply to the [Office of Teacher Education](#) by Jan. 15 prior to the fall semester of the junior year. For more information, contact the Teacher Education Office in GRAD 336. Complete degree with a cumulative GPA of 2.5 or higher. The degree must be posted to your University of Arkansas transcript at the Registrar's Office prior to certification. For more information, please contact the Office of Teacher Education in Peabody Hall (PEAH) 109.

Obtain departmental clearance for GPA requirements, course work requirements, an interview, and/or other requirements. Obtain clearance through an Arkansas Department of Education background check. Note: Another background check will be required prior to graduation in order to be eligible for licensure.

Student is aware that he/she is responsible for meeting enrollment requirements for any scholarships received and is responsible for enrolling in the proper number of hours to meet graduation requirements.

Description of specific change	Justification for this change
Remove AGED 4113 - Undergraduate Researchers Improving Student Experience from degree plan.	Changes to the AGED concentration degree plan are necessary in order to provide our students with a more rounded education in relation to holistically managing an agricultural education program. Changes would allow additional instruction in the areas of managing youth organizations and supervising experiential learning outside of a classroom through an expanded AGED 4233 Program Development course. These are areas in which recent graduates have indicated we need to provide additional instruction. The removal of the AGED 4113 URISE course is necessary because it does not teach skills that are highly sought after by students in our program. The removal of the AGED 3111 Student Management course is necessary because it is repetitive in the concepts taught. Most of the competencies taught in AGED 3111 are also taught in other AGED courses. Any AGED 3111 not covered in other courses can be integrated in the expanded AGED 4213 Teachers as Professionals course. Teachers as Professionals should be expanded to 3 hours to balance credits in the last semester and to provide additional contact time to teach competencies in this area. Currently, the AGED program needs improvement in teacher professionalism TESS standards. 4 credits removed from AGED 4113 and AGED 3111 will be replaced with 4 credits by expanding AGED 4231 to 4233 and AGED 4211 to 4213, adding 2 hours for each course.
Remove AGED 3111 - Student Management from degree plan.	
Changed AGED 4211 - Teachers as Professionals from one hour credit to AGED 4213 three hour credit.	
Change AGED 4231 - Program Development from one hour credit to AGED 4233 three hour credit. This course will change from being offered during the last semester in the degree plan to the spring semester of the junior year. Other electives will be moved to accommodate this change and balance semester credit hours.	
4 credit hours will be removed (AGED 4113 & AGED 3111) while 4 credit hours will be added in expanded courses (2 in AGED 4213 & 2 in AGED 4233) for a net zero change in credits for the degree plan.
