Web-based Program

There are currently eight undergraduate and three graduate social work programs offered in Arkansas, with no online program options available. Providing an online Master of Social Work (MSW) Advanced Standing Program at the University of Arkansas will potentially increase significantly to the diversity and number of students able to complete this valuable degree in the most affordable way possible. Residents in our rural state will benefit from increased access to our graduate social work program, which allows the MSW student the flexibility to continue working while studying for a master's degree in social work and also allows learning in place, all across Arkansas. In many small communities a Licensed Master Social Worker is a valuable asset that is often inaccessible for low to moderate income individuals and families, those with unreliable transportation, those who are mentally or physically ill, and others who experience pain and loss.

MSW Advanced Standing Programs are specifically designed for students who have successfully completed a Bachelor's Degree in Social Work from an accredited program within the last six years. This one-year program provides advanced level courses to social workers with a bachelor's degree, allowing these individuals to quickly begin serving their communities at a higher level, while earning a better living for their families. With a master's degree in social work, students could see an estimated increase in salary of \$15,000 per year. As of November 2014, there were 507 licensed BSW level social workers residing in Arkansas who could immediately apply to take advantage of this opportunity for advancement.

This online degree option will become even more valuable going forward. With eight undergraduate programs in the state, the number of new BSW graduates continues to grow. There are only three MSW programs in Arkansas to serve this expanding pool of BSW graduates potentially seeking a master's degree. The real limits of "bricks and mortar" resources at the three universities offering MSW degrees makes an online program a feasible and cost effective way to serve the growing demand for admission.

An online program will not only be cost effective for the University of Arkansas, but will benefit students as well. Students live and attend Universities all across the state. Many BSW graduates are living and working in areas not close to any of the three Arkansas graduate programs. Working BSW social workers are often non-traditional students who have jobs and families to support. These circumstances mean that moving to attend graduate school is often cost prohibitive for many students. Continuing to live and work in current hometowns while attending graduate school online is an innovative way to help students progress in their careers in an affordable way.

Admission Requirements: Admission to the University of Arkansas Graduate School as well as admission to the School of Social Work M.S.W. program is required. Admission requirements for all of the M.S.W. programs include: a baccalaureate degree with a liberal arts perspective from an accredited college or university (official transcripts must be provided). A personal statement of motivation for and experiences supporting admission to the M.S.W. program; a social needs paper that discusses a current social need that is of concern and interest to the applicant; three professional reference letters (faculty, employers, supervisors); a basic statistics course; and computer literacy demonstrated through prior course work.

Admission to the Advanced Standing Program (on campus or on line). Applicants must have a Bachelor of Social Work from a university by the Council on Social Work Education in the past six years. If the bachelor's degree was earned over six years ago, the applicant may submit a petition for exception, demonstrating a significant history of social work employment and continuing education. Applicants must have a minimum 3.00 undergraduate GPA on a four-point scale for the last 60 hours of the first bachelor's degree. Applicants are exempt from taking the GRE or MAT.

Admission to the two and three year programs. A minimum 3.00 undergraduate GPA on a four-point scale for the last 60 hours of the first bachelor's degree. Two and three year students may be considered for conditional admission with a 2.75-2.99 GPA with the submission of the Graduate Record Examination (GRE) or Millers Analogies Test (MAT) to the graduate school.

Two-year Program Option: This option is available for students without a baccalaureate degree from a program accredited by the Council on Social Work Education. Students in the two-year option must successfully complete a total of 63 credit hours. The following are required foundation courses:

Advanced Standing Option: Students with a baccalaureate degree from a program accredited by the Council on Social Work Education are eligible to apply for Advanced Standing. This option requires a total of 39 credit hours including <u>SCWK 5013</u>, and the advanced course work listed above for the two- and three-year options. Students may complete the advanced standing option on campus or online.

Electives: Each two year student is required to successfully complete three electives (9 credit hours). Each advanced standing student is required to successfully complete five electives (15 credit hours) Electives are chosen in consultation with and with approval from the student's major faculty adviser. Students may enroll in electives outside the School of Social Work, with faculty adviser approval.

Each student is required to successfully complete a population-specific practice course (3 credit hours) from either SCWK 6243. Students may choose to take the other population-specific practice course as an elective.

Elective topics often change from semester to semester based on faculty expertise and student interest. Therefore, it is not possible to guarantee specific electives.

Other Requirements: M.S.W. students are required to complete a capstone paper and presentation. The capstone project is a research experience in the area of practice/program evaluation, guided and evaluated by a panel of faculty and senior social work practitioners from the community. Students may choose instead, with faculty approval, to complete a thesis. The thesis option is guided by the student's thesis committee, resulting in a final paper and oral defense. Both options are completed in conjunction with the three-hour Research and Technology Lourse. Only those choosing the thesis option must enroll in thesis hours in their advanced year.

Change of Program: MSW Students may request an approval of a curriculum change from the Curriculum

Committee in writing should circumstances require that the student is unable to successfully meet the
requirements for graduation on time as projected at admission. The student may request up to two curriculum
changes. This includes changing between MSW programs, and general curriculum extension within the parameters
and constructs of the MSW curriculum. MSW students may extend program completion up to 24-months beyond
originally projected graduation date. This includes any curriculum changes. Request for exception to these
limitations must be made in writing to the Curriculum Committee.

<u>Dismissal from the Program: MSW students can earn two "C" grades toward the MSW degree, provided the</u> student maintains a 3.0 GPA. Students who earn "C" grades are advised to meet with their advisor to discuss any

<u>academic challenges they may be experiencing.</u> MSW students who earn a "D" or "F" grade or more than two "C" grades, including field, will automatically be dismissed from the MSW Program.

The School of Social Work may academically dismiss students whose cumulative grade point average on all graduate course work is above 2.85, but whose work for the current degree is below 2.85. When the School of Social Work anticipates dismissing a student whose cumulative grade-point average is above 2.85, the School of Social Work will notify the student, using the same process as specified in the general probation policy and must also notify the Graduate School. This policy is effective Fall 2023.

Students are expected to adhere to the current NASW Code of Ethics and the Standards for Social Work Education throughout their program of study, including during all courses and field internship experiences. In addition, students are evaluated on their professionalism and adherence to the ethical code. Should a student violate the NASW Code of Ethics or the Standards for Social Work Education, the student may be referred for remediation or to the Student Retention and Success Committee depending on the severity of the violation. Students may be dismissed from the program if they fail to comply with remediation or Student Retention and Success Committee directives. Students who have been dismissed by the program on the basis of unethical or unprofessional conduct may appeal the decision following the procedures outlined under the Unethical and Unprofessional Conduct policy contained in the Graduate Catalog of Studies.
