This experience will improve their ability to discuss technical concepts and findings in an understandable manner, allowing them to engage in discussions and respond to questions from the audience. Visual Communication: Students will create graphs, charts, and tables to represent data and findings visually. Incorporating these visual elements into both their term paper and presentation will help them develop their multimodal communication skills Quantitative Literacy At its core, this project will emphasize applied quantitative analysis. Students are tasked with collecting numerical data, employing statistical techniques, constructing econometric models, performing inference, and interpreting quantitative results. They must grasp complex econometric concepts such as regression analysis and hypothesis testing. For example, a student analyzing the impact of education on income may perform regression analysis to identify significant predictors (e.g., race, gender, etc.) while translating statistical findings into real-world implications, a crucial component of quantitative literacy. Critical Thinking and Ethical Reasoning The project's open-ended nature will encourage the development of critical thinking skills. Students must define their own research questions, prompting them to critically consider which economic relationships merit investigation. They will evaluate various model specifications and compare results, demonstrating judgment about the most suitable methodologies. Furthermore, ethical considerations will often arise in their analyses.
