	Description and justification of the request	Course requirements (fewer than 15 semester hours) were updated to reflect current course offerings. While the edited document appears as though large swaths of the program have been changed, the only courses affected by this change are CIED 6643 Mixed Methods Research Design, CIED 684V Teaching Internship, CIED 6053 Curriculum Instruction: Learner Assessment and Program Evaluation and ESRM 6413 Experimental Design in Education.   Maintain program offerings that are current and consistent with trends in similar Ph.D. programs	Removed "Completion of approved Masters Degree" as a program requirement. Changed the total overall credit hours required to 69 from 102 to reflect this change. \n\nAlso clarified the language regarding GRE to accommodate the Grad School's GRE-optional change.   Removed "Completion of approved Masters Degree" as a program requirement because it is an admission requirement. The overall credit hours has been listed as 102, but the program of study really only requires 69 total hours. Since not all Masters degrees require 33 credits, this has created confusion and disparities between students. Also, "requiring" 102 credits is not accurate because it ostensibly counts the hours counted for the Masters twice. Once for the Masters and once for the Ph.D.
