Requirements

Writing Requirement: All upper-division English courses require a research or an analytical paper except [ENGL 40003](#) and the courses in creative writing ([ENGL 30103](#), [ENGL 40103](#), [ENGL 40203](#)). For this reason all students who fulfill the requirements for a major in English thereby fulfill the Fulbright College writing requirement. In addition, 4000-level courses (except for those noted above) require more intensive research by, and more active participation from, students than 3000-level courses do and require each student to complete a paper that can be included as a writing sample with applications to graduate programs or professional schools.
