#### Requirements

#### Requirements Full Admission to Remain in the Pre-Licensure B.S.N. Program (NURSBS-PLRN)

Full admission to the Eleanor Mann School of Nursing is contingent upon meeting all the conditional requirements and successfully meeting the following requirements:

Students who are accepted into the nursing program must maintain Maintain at least a C or higher in all coursework.

Students who do not maintain All prerequisite coursework for a C or higher fall admission into the Professional Program of Study in all prerequisite coursework after accepting admission Nursing must be completed by the end of the spring semester. All coursework for spring admission must be completed by the end of the fall semester prior to the nursing program will be dismissed.

entering the Professional Program of Study in Nursing. All prerequisite coursework must be completed with a grade of C or above by the end of the first semester in which the student is enrolled in NURS courses.

Students must provide proof of all required clinical compliance paperwork, including drug screens and background checks, before given deadlines. Failure to submit clinical or compliance paperwork by EMSON deadlines will lead to course withdrawal and possible program dismissal.

The minimum number of hours required to receive a baccalaureate degree at the University of Arkansas is 120 semester hours. The nursing major is exempt from the eight-semester degree plan since the program is <u>admission-based</u>. <u>Please refer to the Eleanor Mann School of Nursing website for specific information related to the admission criteria</u>. <u>admission-based</u>.

There is no guarantee that a student meeting the minimal GPA requirement will beadmitted. Please refer to the College of Education and Health Professions website for specific information related to the admissioncriteria. Progression, Withdrawal, and Dismissal

For progression in the nursing program, only grades of "C" or above will be accepted. Students who make less than a "C" may not progress into courses for which that course is a prerequisite until the course is repeated and the required minimum grade attained. Note that the Eleanor Mann School of Nursing uses the following grading scale and exam policy: If a student earns a "D", "F", or "W" in a course, the course may be repeated once. The course must be passed on the second attempt. If a student earns a D, F, or withdraws from the second attempt, this results in dismissal from the nursing program without eligibility for readmission.

If If a student earns a "D" second "D", "F", or "F" "W" in a second any course, the student will be dismissed from the program and will not be eligible for re-admission.

<u>re-admission.</u>Note that the Eleanor Mann School of Nursing uses the following grading scale and exam policy: Grading Scale: A = 92 - 100% B = 83 - 91% C = 75 - 82% D = 62 - 74% F = below 62%

Exam Policy: A 75% average on class exams is necessary to pass the course. Once this criterion is met, other course grades will be factored into the final grade. The total exam average is calculated by the total earned exam points divided by total available exam points. An average of 74.50% to 74.99% will be rounded to achieve the 75% minimum.

The proctored ATI testing requirements embedded within courses are mandatory; they must be completed in full for a final grade to be awarded in each course. If the required level of achievement is not passed, remediation and retakes are required. Required retakes must be taken prior to being allowed to take the ATI Comprehensive Predictor exam. Failure to follow or complete the remediation instructions for any ATI proctored exam may delay a student's ability to progress in their degree plan and may delay graduation.

ATI Comprehensive Predictor Exam: Remediation of the Comprehensive Predictor (and retake if applicable) must be completed in full for a final grade to be awarded in each course. If each component of the required remediation is not complete before the end of the course, students will not be approved to graduate or take the NCLEX-RN exam until requirements are met.

If a student earns a "D", "F", or "W" in a course, the course may be repeatedonce. The course must be passed on the secondattempt. If a student earns a second "D", "F", or "W" in any course, the student will be dismissed from the program and will not be eligible forre-admission. Students Students who do not pass the Dosage Calculation Exam per handbook policy, will be administratively withdrawn from the respective clinical practicum course. course and associated co-requisite courses. This may lead to a delay in graduation and/or dismissal from the program. See handbook for details. A positive background check may impact clinical placement and eligibility for licensure. Confirmation of a positive drug screen or ethical violation will result in administrative withdrawal from nursing courses and nursing program dismissal.

A positive background check may impede or halt the student's progression in the program and may impact clinical placement and eligibility for licensure. If a student is arrested during their program of study, the school of nursing should be notified immediately, and the and the student will become ineligible for clinical courses pending the outcome of an investigation and/or judicial process. Failure to report is considered a violation of the Code of Ethics.

The school of nursing will comply with the policies, rules, and regulations set by the Arkansas State Board of Nursing.

Failure to comply with state board rules and regulations will result in program dismissal.

All compliance documentation must be submitted by the student to their personal EXXAT account by the assigned due dates. Didactic/Professional Role Implementation Courses Failure A student who needs to meet compliance requirement deadlines for clinical practicum courses will result repeat a course in a Performance Improvement Plan and administrative withdrawal from which they were unsuccessful must submit a petition to the course, which may delay progression Student Affairs Committee in nursing and are encouraged to do so as soon as they are aware of the program. need to repeat a course. Also, a student dismissed from a Professional Role Implementation Course due to safety, ethical, or dishonesty issues will be administratively withdrawn from a course, and may be subject to administrative withdrawal from the School of Nursing following a fullreview. Readmission is not guaranteed to thesestudents. Students should note that any violations of the Eleanor Mann School of Nursing policies, standardized safety practices, or code Code of ethics Ethics can result in course failure and/or dismissal from the program without prior warnings (see student handbook). warnings (see Student Handbook).

Three Performance Improvement Plans are evidence of a pattern of behavior that contradicts our policies and code of ethics. A student with three Performance Improvement Plans will meet with program administration and will be subject to dismissal without readmission eligibility.

A student dismissed from the school of nursing will be asked to self-withdraw from all courses or will be subject to administrative withdrawal. These students are ineligible to request a letter of good standing from the EMSON.

#### **Didactic/Professional Role Implementation Courses**

A student who needs to repeat a course in which they were unsuccessful must complete an Academic Success Plan and are encouraged to do so as soon as they are aware of the need to repeat a course. An academic success plan will be

implemented upon approval as outlined by the student's academic advisor and the Program Coordinator. this committee.

Students will be readmitted on a space-available basis according to the following priority system:

#### **Readmission Policies**

Any student whose enrollment in the professional program of study has been interrupted may seek readmission following the steps below:

Seek readmission into the University of Arkansas (if applicable).

Complete Readmission Application to the School of Nursing during the application periods. (Readmission is limited by space availability).

Readmission will not be considered for any student dismissed from the School of <u>Nursing</u>. Nursing who obtained a "D" or "F" in one nursing course and was unable to make a "C" or better upon repeating this course or who was dismissed from a Professional Role Implementation Course due to safety, ethical, or dishonesty issues.

Exceptions to this policy will be considered by the Student Affairs Committee in nursing on an individualbasis. Exit Policies

Students must complete the requirements for the degree within five years of enrolling in the first upper-division nursing course. If the student does not complete the Professional Program of Study within the five-year limit, nursing credits must be reevaluated and may need to be repeated. reevaluated.

All University of Arkansas requirements must be met.

In addition to the program requirements, students must meet the university and college graduation requirements. This curriculum is subject to change to comply with national accreditation and the Arkansas State Board of Nursing Standards.
