This change modifies the ELELBS pre-program hours required before candidates make admission to the ELELBS program.</p>	<p>This change modifies catalog language to clarify admission policy changes made to the ELELBS. The changes to the CHED and ELEL programs are being made in response to the Arkansas Department of Education's (ADE) significant revisions of the competencies required for K-6 elementary teacher education programs. In making the changes, program faculty consulted ADE's required content competencies, the content addressed in the Praxis and new state required Reading Exam candidates must pass to obtain licensure, various national and state standards documents, and leading research in the elementary education field.</p>
