## **Program Requirements and Description**

### Requirements

For students interested in obtaining both the M.B.A. and J.D. (law) degrees, the M.B.A./J.D. dual degree program is available. This program allows the student to receive both the M.B.A. degree and the J.D. degree.

The program requires separate application and admission to both the School of Law and the Graduate School of Business and the M.B.A. degree program. Interested students should obtain bulletins and applications from both the School of Law and the Graduate School of Business.

If the student is accepted into both programs, a maximum of  $\underline{\underline{6}}$  12 hours of approved law core courses may be used as duplicate credit toward the M.B.A. degree. These  $\underline{\underline{6}}$  12 hours of law core courses shall be applied to the  $\underline{\underline{6}}$  12 hours of elective career track courses within the M.B.A. degree plan. Likewise, a maximum of  $\underline{\underline{6}}$  12 hours of approved M.B.A. core courses may be used as duplicate credit toward the J.D. degree, thus reducing the total time necessary for the completion of both degrees. Students pursuing the dual degree plan must begin their academic program in the School of Law.
