Please edit justification in LON to make it read better. there seems to be a lot of missing words. Please remove typical 8-week plan from requirements section. under description of change, remove all justification. You are simply requesting a new graduate certificate in Homeland Security. Streamline the justification section too.

Per Provost, remove Little Rock Downtown site from LON and request in course leaf. He wants Walton to make the request to HLC. We can add it later.

In this way, given our internal market analysis, it presents little downside viability risk and indeed may enhance recruitment for the degree program both directly and perhaps also as a pipeline for anyone who takes it on a stand-alone basis."
