## Program Requirements and Description

### Requirements

**Admission to the Master's Degree:** ~~University of Arkansas Graduate School. Prerequisites to Degree Program.~~ The normal preparation for graduate study in comparative literature and cultural studies is an undergraduate **degree in world languages, English, or a related field in the**

humanities masters degree in English or foreign languages and the social sciences. literatures. Applicants should have advanced proficiency in the intended languages of study. Admission requirements: at least one foreign language.

#### Application to the Graduate School

The program may also accept students with undergraduate or master's degree in the humanities, the social sciences, and other relevant fields under the condition that any deficiencies in literature or foreign languages be completed in addition to the requirements for the degree. Admission Requirements: The following materials must be submitted to the Director of the Comparative Literature and Cultural Studies program: Application for Admission to Graduate Study in Comparative Literature and Cultural Studies. The form is available from the Program Director and the program's Web page. Admission to the University of Arkansas Graduate School. Graduate Record Examination (GRE) scores on the Aptitude Test (verbal, quantitative, and analytical writing). International students are required to take the Test of English as a Foreign Language (TOEFL) or the International English Language Testing System (IELTS) exams, meeting the minimum score required by the Graduate School. Complete official transcripts of all undergraduate and graduate work.

work. Graduate Record Examination (GRE) scores on the Aptitude Test (verbal, quantitative, and analytical writing).

International students are required to take the Test of English as a Foreign Language (TOEFL) or the International English Language Testing System (IELTS) exam, exams, meeting the minimum score required by the Graduate School.

Three letters of recommendation from former teachers, employers, or supervisors. An examination paper from a literature course, including essay answers, or a term paper or other evidence of writing ability. Statement of purpose describing academic interests and professional goals.

#### A Curriculum Vitae

An academic writing sample, demonstrating critical thinking, writing ability and research potential (10 pp approximately)

Doctoral applicants must specify which track they wish to pursue: comparative literature, modern languages, cultural studies or translation. Three letters Requirements for the Master of recommendation

Requirements for the Master's Arts Degree: In addition to the general requirements of the Graduate School, all master's candidates must meet the following requirements:

All master's candidates must take WLIT 5193 ~~WLIT 5193~~ Introduction to Comparative Literature and COMM 5503 ~~COMM 5503~~ Communication and Cultural Studies

are required of all candidates in the master's program. All Each master's candidates candidate must take 6 complete 36 hours of world languages course work or 30 hours of course work and literatures in areas and historical periods different from their primary fields. six hours of thesis. All master's candidates are required to take and pass a comprehensive examination based on course work taken. Students may retake only once any examination they fail.

Master's candidates intending to enter the Ph.D. program are recommended to choose the thesis option. All courses selected must be approved by the adviser, who will consult with the other members of the Master's Program Advisory Committee. Master's candidates in the thesis option must take 12 hours of graduate course work in a first field and six hours of graduate course work in a second field (Arabic, Classics, English, French, German, Spanish, and courses in other disciplines in the humanities and the social sciences). Master's candidates in the non-thesis option must take 12 hours of graduate course work in each of two specialty fields (Arabic, Classics, English, French, German, Spanish, and courses in other disciplines in the humanities and the social sciences). All master's candidates must take a minimum of six hours in world literature and cultures. WLIT 5193 Introduction to Comparative Literature and COMM 5503 Communication and Cultural Studies are required of all candidates in the master's program. All master's Master's candidates who choose cultural studies as one of their fields must demonstrate reading proficiency in a language other than English. The language requirement may be fulfilled either by taking 12 hours in the target language or by taking the reading exam administered by the Department of World Languages, Literatures, and Cultures. Documented coursework from an accredited institution in which the language of instruction is other than English may be used to substitute for a language exam. Foreign Languages.

#### Requirements of the Thesis Option

Candidates Master's candidates in the master's thesis option must complete 30 take 12 hours of graduate course work in a first field and 6 thesis hours. six hours of graduate course work in a second field (Arabic, Classics, English, French, German, Spanish, and courses in other disciplines in the humanities and the social sciences). Master's candidates intending to enter the Ph.D. program are recommended to choose the thesis option.

Candidates will All master's candidates must take 6 hours a minimum of course work six hours in world literature and 6 thesis hours in their primary area of concentration. cultures.

Candidates will Master's candidates in the non-thesis option must take 12 hours of graduate course work in a second field (other literary tradition or cultural studies). each of two specialty fields (Arabic, Classics, English, French, German, Spanish, and courses in other disciplines in the humanities and the social sciences).

Each master's degree candidate is required to take and pass a comprehensive examination. Master's candidates in the thesis option must present a thesis proposal early in their second year of study and must turn in the thesis during the last semester of course work, following Graduate School guidelines for thesis submission.

Theses in a language other than English. Students in the Comparative Literature and Cultural Studies Program may request permission to submit their thesis in a language other than English, with legitimate justification. Valid reasons for submitting a thesis in a language other than English includes the subject matter, special primary audience, publication venues, academic position in a foreign country, historical or literary value, and the documents to be used, analyzed and interpreted. Limited English writing skills is not a valid justification. Students must request approval of the target language from the thesis committee, the program advisory committee, the program director and the dean of the graduate school before starting the project. All committee members must be proficient in the target language and approve target language usage. Abstracts must be written in English.

Candidates in the thesis option are only required to take the world literatures and cultures comprehensive exam.

#### Requirements for the Non-Thesis Option

In addition to the general requirements, Master's candidates in the non-thesis option must select two fields and complete 12 hours of graduate course work in each field (Arabic, Classics, English, French, German, Spanish, and courses in other disciplines in the humanities and the social sciences).

Candidates are required to take two comprehensive exams. One is on the specialty fields and one is on the selected areas of world literatures and cultures.
