





Market is getting saturated in central Arklansas with the arrival of about 5 new hotels in the last two years.

The degree will help locally based retailers, as well as retailers based across the nation, as design firms continue to become "one-stop shop" for all things retail. Firms are attempting to capture new retail clients, and keep existing ones, by expanding services such as space planning, branding, prototype development, energy conservation, etc. A degree with an emphasis on retail would allow the designer to be more competitive and thrive in a retail-oriented firm.

It would provide more professional degrees for Interior Designers. None, to my knowledge, are currently offered in the state. 




